### **MUXLOC DEFINITION**

- Multiplexing Location Identifies the Common Language Location Identification (CLLI) code of the provider central office which provides multiplexing for a service riding a High Capacity service.
- MUX is associated with the Connecting Facility Assignment (CFA) which is one level above the service being ordered.
- Required when utilizing multiplexing services and the ACT field on the Access Service Request (ASR) is "N" or "C", otherwise optional.

This Customer Education Package and the instructions on how to populate the MUXLOC field does not apply to BellSouth® SMARTGate® service (a.k.a. BellSouth SPA Managed Shared Ring Network) or to BellSouth® SMARTRing® service (a.k.a. BellSouth SPA Dedicated Ring).

**CLLI CODE** consists of the following elements.

- Geographical Code: positions 1-4, a municipality, 4 alpha characters
- Geopolitical Code: positions 5-6, designation of a state, 2 alpha characters
- Network Site Code: positions 7-8, designation of a site within a geographical location, 2 alpha or numeric characters
- Network Entity Code: positions 9-11, describes the functional category of equipment, 3 alpha/numeric characters
  - Example: ATLNGACSK12
