- CMRS switch sends pANI and CBN (ERSD & CBN). The pANI MUST be in the Generic Digits Parameter (GDP), and the CBN MUST be in the Calling Party Number Parameter (CBN is allowed in the Charge Number parameter in addition to being the Calling Party Number parameter, but Charge Number parameter is ignored by the BellSouth E911 Tandem). NENA Table 4-2 ISUP Parameter Options: A1, A2, B1, B2, C1, C2, D1, D2, I1, I2, J1, J2, K1, K2, L1, L2.
- CMRS switch sends pANI and CBS (ESRD & CBN). The pANI MUST be in the Called Party Number parameter, and the CBN MUST be in the Calling Party Number parameter. (CBN is allowed in the Charge Number parameter in addition to being in the Calling Party Number parameter, but Charge Number parameter is ignored by the BellSouth E911 Tandem.) NENA Table 4-2 ISUP Parameter Options: E1, E2, F1, F2, G1, G2, H1, H2.
